MEMBERSHIP TERMS & CONDITIONS

1. All Membership Fees, Registration Charges, AMC and all payments made are strictly **NON-REFUNDABLE, NON-ADJUSTABLE and NON-REVERSIBLE**. Once the membership is activated or used even for a single day or facility, the entire membership amount becomes **NON-REFUNDABLE without exception**.
2. The Management reserves absolute rights to allot, reject, suspend or terminate membership without assigning any reason.
3. The Member declares his and his families medical fitness and accepts full responsibility for health conditions, injuries, accidents or complications arising from gym, swimming or other physical activities.
4. The Member voluntarily assumes all risks related to participation in club activities and waives any claims against **The Stellaar – Premium Family Club, Triovertical Megaventure Pvt. Ltd., its Directors, Management, Employees, Trainers and Associates**.
5. The Club shall not be liable for any injury, accident, illness, loss of life, theft, loss of personal belongings or property damage occurring within club premises or during club activities.
6. The Member agrees to **indemnify and hold harmless** the Company, its Directors and Staff against any claims, losses, damages or legal actions arising due to negligence, misconduct, guest behavior or misuse of facilities.
7. All facilities including Gym, Swimming Pool, Salon, Restaurant, Banquet Hall, Business Lounge, Indoor Games and Conference Rooms are subject to availability and shall operate on **first-come-first-serve basis**.
8. The Company shall not be liable for any delay, interruption, suspension or failure in performance of services due to **force majeure events including but not limited to Act of God, natural calamities, pandemic, government restrictions, accident, fire, power failure, technical disturbances, strikes, civil unrest or any circumstances beyond Company control**.
9. The Club reserves the right to operating hours, policies, modify services, amenities or pricing and temporarily suspend any facility due to maintenance, renovation, safety, events or operational requirements without refund or compensation.
10. Misbehavior, misconduct, harassment, nuisance creation or actions harming the brand reputation may result in immediate suspension or termination of membership without refund.
11. Formation or participation in disruptive groups, nuisance activities or any action damaging the reputation of the Company or its Directors is strictly prohibited and may result in immediate termination of membership.
12. All service bills must be settled immediately. **No credit facility is permitted**.
13. Payment default attracts **₹2,000 penalty per default with 24% annual interest** on overdue amount. Three defaults shall result in automatic termination of membership.
14. Entry will be restricted if Membership Fee or AMC is overdue.
15. **AMC is applicable from 1st January to 31st December** every year irrespective of joining date. Non-payment beyond 15th January shall restrict access and non-payment beyond **31st January** may result in termination. AMC charges may be revised by the Company without prior notice and I/We agree to the same. **For the last year of membership**, AMC shall be charged proportionately as per the balance months remaining in that calendar year.
16. Guests are allowed only when accompanied by the Member in designated areas with applicable charges. Maximum four guests allowed at a time in restaurant. Management reserves rights to deny guest entry.
17. Outside food is prohibited. Eating is not permitted inside Gym, Swimming Pool or Activity Areas except designated food zones.
18. Smoking and use or consumption of alcohol, narcotics, drugs, gutka, kharra or any prohibited substance is strictly not permitted within Club premises except in permitted bar area(s), if applicable. Any person under the influence of alcohol shall be allowed entry only in permitted bar area(s) and shall not be permitted to access amenities areas, reception, office or operational areas. Any violation, misconduct or unauthorized entry under such influence shall result in immediate termination of membership without refund, excuse or delay. Strictly to be followed. The Club, company, its associates or sister concerns reserves absolute rights to refuse or deny sale/service of alcohol to any person who, in the opinion of the Management or staff, may be unable to handle alcohol consumption or may create disturbance, nuisance or safety concerns. Such decision of the Management shall be final and binding without requirement of assigning any reason.
19. Proper sports attire, activity-specific costumes and separate workout shoes are mandatory.
20. Membership is non-transferable except with prior written approval of Management. Transfer within 3 months is chargeable at **₹50,000/-** and thereafter at **50% of prevailing membership value**, subject to Management approval.
21. Any damage to Club property shall be compensated by the Member as assessed by Management.
22. Locker key loss penalty **₹500**. Duplicate Membership Card charge **₹500**.
23. Entry is permitted only on production of valid Membership Card or authorized biometric verification.
24. The Member authorizes the Club to send communication related to events, promotions and updates via calls, SMS, WhatsApp and email.
25. The Member gives full consent that **any photographs, videos or media captured by the Company during the membership tenure or club events shall remain exclusive Company assets** and may be used for marketing, branding, promotions, advertisements, social media or commercial purposes as and when required. **No claims, objections or compensation demands by the Member or any other person shall be entertained**.
26. If the Member opts for the **"Stellaar Select Program" (if applicable)**, the Member agrees to follow all rules and policies of associated clubs or properties. The Member understands that **entry and access shall be at the sole discretion of the respective affiliated property** and subject to availability. The Member further agrees that **partner list, access privileges and discounts may be changed, added or removed at any time without prior notice or compensation**, and no claims or legal challenges shall be raised for the same.
27. Gambling, betting or any illegal gaming activity inside Club premises is strictly prohibited. Violation may lead to immediate suspension/termination of membership without refund and legal action.
28. If any member is convicted/proven guilty in any criminal case by a court of law, Management may immediately suspend or terminate membership without refund.
29. The Member acknowledges that the Club is a corporate entity and management structure may change without affecting membership obligations.
30. All disputes shall be resolved through **Arbitration under the Arbitration and Conciliation Act, 1996** by a Sole Arbitrator appointed by Triovertical Megaventure Pvt. Ltd. Arbitration venue shall be **Nagpur, Maharashtra**. Courts at Nagpur shall have exclusive jurisdiction.
